The committee agreed to the submission of the ecological briefing note, as advised by KHPC's legal team and commissioned ecologist. The ecologist had confirmed the merit of producing a briefing note addressing both ancient woodland concerns and deficiencies in the wider ecological assessment produced by the planning while raising strategic applicant. considerations around timing and communication.

It was acknowledged that the note had been submitted to TMBC prior to the issuance of the Decision Notice, as post-decision evidence was significantly harder to introduce. It was further noted that the Legal advisors had cautioned against notifying TMBC of the note's imminent submission, as this could prompt early release of the Decision Notice.

Residents who attended were thanked for their contributions and invited to continue engaging with the Parish Council as this matter progresses.

TMBC Changes to Planning Committee Speakers: The committee considered correspondence from East Peckham Parish Council (EPPC) outlining concerns about recent changes to public speaking rights at TMBC's Area Planning Committees. Key issues raised included housing allocation, transparency, engagement, and the fairness of speaking arrangements. It was agreed to robustly endorse EPPC's views, recognising the importance of balanced representation and meaningful public participation in planning decisions. KHPC would support calls for greater consultation, clarity, and fairness in TMBC's approach and welcomed constructive dialogue with neighbouring parishes and the borough council. Agreed
